I understand that the photos and other media that the Producer will provide in the course of and/or after **the 27<sup>th</sup> National Selection Conference of EYPCZ Liberec 2025** from **26<sup>th</sup> March** to **30<sup>th</sup> March 2025** in **Liberec, Czech Republic**, as part of their work for the Media Team of the event, will be used by the European Youth Parliament CZ (Evropský parlament mládeže v ČR, z.s.).

I hereby grant shared user rights under copy right that may exist regarding the media produced at this event and provided to the European Youth Parliament CZ and share all copyrights to the European Youth Parliament CZ for non-profit use.

I confirm that the Producer is the author of the work and that the work does not defame any person, nor does it violate the right of privacy or any other right of any person.

I confirm, without limiting the foregoing, that the European Youth Parliament CZ has the unlimited, worldwide, irrevocable right to create derivative new works based, in whole or in part, on the Producer's work, and the right to remix, tweak, and build upon the Producer's work and to use it in any manner for European Youth Parliament CZ's purposes that seem appropriate at European Youth Parliament CZ's sole discretion.

I release and discharge the European Youth Parliament CZ from any and all claims, demands or causes of actions that the Producer has or may have in the future for libel, defamation, invasion of privacy<sup>1</sup> or right of publicity, infringement of copyright or trademark, or violation of any other right arising out of or relating to any use of the rights granted under this agreement.

I waive of any kind of payment and reaffirm that the European Youth Parliament CZ has the right to redistribute the pictures with non-commercial interest to partners of the European Youth Parliament CZ and to the EYP network.

This transfer and waiver is irrevocable. The place of jurisdiction is Czech Republic. This contract is subject to Czech law regardless of the place where the documented events take place.

- This form makes sure that the European Youth Parliament CZ has the rights to use the media content produced by you at this European Youth Parliament CZ session.
- After signing this form you are still allowed to use pictures, texts, videos etc. that you produce for your own purposes. You are free to publish them on your social media pages, blogs, websites, and/or include them in your portfolios.
- You are not entitled to give the media products from an EYP session for the use of another organisation, whether for-profit or non-profit. You may be allowed to use the media content you produced for commercial products or any profit purpose, but only with prior written consent by the European Youth Parliament CZ.
- Authorship remains with the media team member and will be named at every use if the name of the author of the work is clearly passed on to the European Youth Parliament CZ.
- If you are an editor or editorial assistant: make sure to name pictures with dates and photographer names in full in order for the European Youth Parliament CZ to be able to name the photograph's author when republishing the pictures.
- Make sure to write into the metadata of pictures and videos the authors of the work. Make sure to clearly state authors of texts for later reference.
- All session participants are asked before attending to consent to being in pictures and other material that is produced by the media team. However, with the clause "the work does not defame any person" we draw your attention to good ethics and taste when it comes to publishing pictures or other material. Make sure that people always feel comfortable about the way they are presented in your work.
- Although not stated in this form, please respect the [EYP Communication Manual](#) guidelines at all times and make sure to study its content before attending the EYP session as a media team member.
